HOW TO USE THIS ENTRY FORM

1. All entries must be submitted on the official entry form.
2. You may use one entry form to enter the same dog in more than one field event on the same weekend.
3. Use a separate entry form for each dog to be entered in a club's field events.
4. Mail all completed entry forms plus entry fees to the Field Trial Secretary as listed under the event notice unless otherwise specified.
5. Make all fees payable to the host club.

We want you to keep the points earned at licensed UKC events. *Important things to remember:*

- All dogs entering UKC events must be permanently registered, have a valid Temporary Listing Number, or a Limited Privilege number for performance events.
- All entry forms must be complete and signed. Incorrect information submitted on the entry form may invalidate your wins.
- To be eligible for the T.A.N. events, the dog must be less than 3 years of age on the day of the event.
- To be eligible to enter the Open Braces class in a field trial the dog must have earned a First Place or Reserve in Open solo competition.
- Dogs with breed disqualifying faults may not enter Field Trial competition

RELEASE AND WAIVER OF LIABILITY

All events are held under the Official Rules and Regulations of the United Kennel Club, Inc. Absolutely no alcoholic beverages or illegal drugs will be allowed on the grounds or in the buildings on the day of a UKC-licensed event. UKC, including but not limited to its agents, officers and employees, and the host club (to include its agents, members and officer) assume no responsibility for any loss, damage or injury sustained by spectators or by exhibitors and handlers, or to any of their dogs or property, and further assume no responsibility for injury to children who shall be deemed to be under the control of their parents or guardians. UKC and the host club are not responsible for loss, accidents or theft. By signing this form and being allowed to be present and/or participate, I hereby agree to release, remise and waive any claim, demand, action, or lawsuit and further agree to indemnify and hold UKC, the host club (including their members, directors, officers and agent), any approved UKC Judge and the owner(s) operator(s) or Lessors of the premises and any agents/officer/employees/members of the aforementioned parties harmless from any claims, demands, actions or lawsuits resulting from y presence and participation in this event, along with any action, decision or judgment made by any UKC or host club representative or approved Judge under the official UKC Rules and Regulations governing this event. I (we) agree to hold harmless the UKC, sponsoring club and aforesaid parties from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or upon the event premises or grounds or near any entrance thereof, and I (we) personally assume all responsibility and liability for any such claim and I (we) further agree to hold the aforementioned parties harmless from any claim for loss of this dog by disappearance, theft, death or otherwise, and form any claim for damage or injury to the dog, whether such loss, disappearance, theft, damage or injury be caused or alleged to be caused by the negligence of UKC, the club or any of the parties aforementioned, or by the negligence of any other person, or any other cause or causes. I (we) hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries including death at any time resulting therefrom, sustained by any person or persons, including myself(ourselves), or on account of damage to property, arising out of or in consequences of my (our) participation in this event, however such injuries, death or damage to property may be caused, and whether or not eh same may have been caused or may be alleged to have been caused by any at or omission of the aforementioned parties or any of their employees or agents or any other persons.
